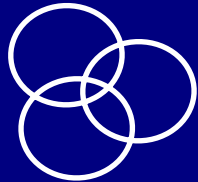

## Fall Protection Training 2011 Accrediting & Auditing Fees

### Applicants need to:

- Be an IEC Plant, SCA Member, or Building Trade
- Complete initial application and review process
- Attend the class as a participant
- Participate in an in-depth review of course components
- Successfully deliver the course under review by an STS Auditor and the STS Fall Protection Training Specialist
- Complete an orientation of associated documents and forms
- Sign a Trainer Agreement
- Submit to a course delivery audit within the first year, and then annually.
- Be or become a Registered Training Provider

### Safety Partnership Vision

*The Safety Partnership vision is to get workers to the job-site trained and ready to work in a timely and cost-effective manner.*

### Registered Training Providers

- are IEC Plants, SCA Members, or Building Trades authorized to deliver accredited safety training courses using an Accredited Trainer
- They must meet and maintain essential standards of performance that support quality standardized training and records management
- Registration Fees are \$425 for the first year and then \$125 annually
- These fees are to register the training organization only, and apply annually
- Additional trainers and training courses may then be added on a per trainer fee basis without additional registered training provider fees to the organization
- These fees are not included in the per trainer fee schedule shown below

### Fall Protection Training Accreditation Fees Per Trainer

|-----------------------|------------------|
| <b>Initial Fee</b>    | <b>\$1100.00</b> |
| <b>Annual Renewal</b> | <b>\$350.00</b>  |

#### Note:

- Organizations must be either current Registered Training Providers, subject to the ongoing \$125 annual renewal fee, or
- Register as a new Registered Training Provider, subject to the \$425 initial fee
- Fee includes Initial Fall Protection Training Course and 3 yr Refresher
- Additional trainers may be added immediately or at a later date
- **Fees in effect as of January, 2011**

### How were these accreditation fees determined?

- Fees are based on a revenue neutral cost-recovery model
- Costs were determined using a pilot accreditation process

- Sarnia Construction Association
- Safety Partnership Operational Committee.
- IEC Executive Committee

### What are the benefits to my organization?

If you train a lot of workers you can save money. You will need to train about 20 individuals per trainer in year 1 and approximately 6 workers per trainer annually thereafter to break even

If flexibility in scheduling is what you need then becoming a Registered Training Provider may be a good fit for your organization

Fall Protection-\$90.00 + HST  
3yr Refresher - \$50.00 + HST
